Dear Judge Hellerstein:

We are the attorneys for Defendants VEREIT, Inc. (f/k/a American Realty Capital Properties, Inc.) and VEREIT Operating Partnership, L.P. (f/k/a ARC Operating Partnership, L.P.) in the above-referenced matter. We write on behalf of all parties to request a modification to the definition of the class in this case (the "Class Definition").

As discussed with chambers yesterday, we jointly propose that the phrase "during the period from February 28, 2013 through October 29, 2014," currently in the Class Definition (see Dkt. No. 859 (May 16, 2014)), be modified to read: "during the period between February 28, 2013 and October 29, 2014." This modification is consistent with the Class Definition in the operative complaint (Dkt. No. 312 (September 30, 2016)) and Plaintiffs' Motion to Certify Class (Dkt. No. 367 (March 15, 2017).)
